*Jurisdiction:* Refers to state, territory or district where a board of nursing is located. May also be used to refer generally to the board of nursing in a particular jurisdiction.


Board Staff: Staff of the board of nursing

**Executive Officer:** Person responsible for running the board of nursing. Includes any other terminology to refer to that authorized person (i.e. Executive Director)


Board Member: Member of the governing body of the board of nursing as outlined by statute

Practical nurse or PN: Licensed practical or vocational nurse (LPN/LVN)



#### Q1. What is the total number of mandated board members?




## Q2. How many RNs are mandated for inclusion as board members?




#### Q4. How many advanced practice registered nurses are mandated for inclusion as board members?












#### Q11. Are specific nurse work settings or roles mandated for board members? (Check all that apply)






#### Q12. Are nurse board members required to be currently employed in nursing at time of appointment/election?








# Q16. Are consumer board members excluded from participation in selected functions/duties of the Board of Nursing?






#### Q22. Who appoints/hires the Executive Officer?






## Q25. How many regular board member meetings were held in the last fiscal year?






#### Q38. What percent of the budget is allocated for education program approval?

# Q39. What type of account receives the revenue generated by the Board of Nursing (e.g. license fees, renewal fees, etc.)?





Board of Nursing revenue account




#### Q40. Does the Board of Nursing have a fund balance?






#### Q43. How is the newsletter distributed? (Check all that apply)








